Newly Acquired Pets:

- Must be licensed within 30 days of ownership
- <OR> at 4 months of age if puppy/kitten

New Residents to Omaha:

Must license pets within 30 days of residency.

If you own one or more dogs in this group, you must also comply with the following requirement to complete licensing:

Provide proof of current personal liability insurance in the amount of \$100,000 or greater. If you have not already provided this information to the Nebraska Humane Society, include a copy of your current declaration page with your license payment. (Copies will not be returned to you)

<u>CHECK PROCESSING POLICY</u> - By sending your check, please be aware that you are authorizing the Nebraska Humane Society to use the information on your check to make a one-time electronic debit from your account at the financial institution indicated on your check. This electronic debit will be for the amount of your check; no additional amount will be added.
